North School is to be demolished according to Hermosa School Superintendent Pat Escalante last Wednesday evening!

However, that's not what it says in the Measure-S legal documents in the Sample Ballot!

Voters are expected to blindly authorize a blank check of \$59 Million to this obviously deceitful bunch, and by doing such, place a \$1/8th billion tax burden on Hermosa Beach Property Owners and indirectly of course resident-renters for 25 to 30 years.
